D. Declaration

I, the undersigned, do hereby declare that I am the registered customer or his legal representative or authorized signatory, who is authorized to request portability for the telephone number(s) above, and there is no other registered customer for the number(s), except if I authorized my legal representative with the attached power of attorney.

1. The receipt of the portability request form does not constitute an undertaking by the incoming operator or the outgoing operator that the portability of the number will be executed. The outgoing operator is entitled to refuse the request for portability for reasons set down in the law.
2. If the portability is executed, it will be for the number(s) only, and all the content and services that were assigned to the number(s) with the outgoing operator, will not be transferred with the numbers. The portability of the number(s) constitutes the severance / removal of the outgoing operator of the number(s) and of all the services and content that existed through these number(s). The requested services and content should be ordered from the recipient operator.
3. I am aware that it is possible that some of the messages that are sent to the number that was transferred) - for example text messages that are distributed by various parties) - will not be rerouted by the outgoing operator to the incoming operator.
4. I have been recommended to notify users, or other paying parties, who are not registered customers for the line, with regard to the portability and cessation of the services.
5. I am aware that portability does not exempt me from any payment and/or debt and/or undertaking involving the outgoing operator, including equipment or existing infrastructure of the outgoing operator.
6. I am aware that during the portability process, services will be temporarily disrupted for the transferred number(s).
7. I am aware that if I have a 'kosher' number that is enshrined in the agreement with the 'Rabbinical Council', then the transferred number will only be a 'kosher' number that is enshrined in the agreement with the Rabbinical Council with the incoming operator as well.
